TINY CHURCH WITH GOD-SIZED MINISTRY

Clayton-Harris Memorial UMC is about as far from any place as you can find—at least in Indiana. Located near Tobinsport on the Ohio River, in Perry County, they are a congregation of less than 10 folks worshipping each Sunday. They began a food pantry ministry in nearby Cannelton, IN in 2005, at its sister UMC church. Then, in 2008, they moved into a building owned by The Oaks Senior Citizens Center. For many years the food pantry was open two days per month and served upwards of 75 families.

Late in 2019, they were told that the building they were using was going to be for sale and they would have to find a new home for their ministry. As they could not find a suitable place for their pantry, they considered closing altogether.

One day, a member of the pantry team, Pat Jones, was talking with a man who told her that, while the building was worth \$90,000 to \$100,000, there wasn't much interest in the small town of Cannelton. If someone offered \$20,000 he thought the owners might take it. As she was driving home, she thought to herself, "We have just over \$20,000 in our church's savings account." After a meeting at the church, it was quickly decided to use the money to buy the building.

Clayton-Harris Memorial applied for a grant with the United Methodist Foundation, and UMFI was thrilled to partner with them in this amazing ministry. Praise God, the Cannelton Food Pantry multiplied its ministry just in time for a COVID-19 crisis. By December of 2020, volunteers were working 2-3 days per week. In addition, Cannelton Food Pantry:

- Served 183 families on average per month.
- Had 1,843 total visitors.
- Received 43,000+ pounds of food from Tri-State Food Bank.
- Purchased 13,000 pounds of food.
- Donors gave another 12,000 pounds of food.
- Hosted the Farmers to Families food box distribution, including 160,000 pounds of dairy, produce, and meat.
- Delivered 300 food boxes to three low-income developments in Cannelton.
- Distributed over 228,000 pounds of food in Cannelton and the surrounding community.



Currently the food pantry is considering whether to be open more days during the week. The UMFI grant of \$5,000 was used to purchase one commercial refrigerator and two desperately needed commercial freezers.

They say, "good things come in small packages." In this case, we could say "great" things come in small packages. Thanks, Clayton-Harris Memorial church. You are a vital congregation and an inspiration to us all. It is our joy partnering with you to keep families fed in Perry county.

GRANTS

UMFI awarded \$726,260 in grants and scholarships in 2020. Seventy six churches and agencies received grants, 18 seminary students received scholarships, 5 active clergy received new tires to allow them to visit their members in safety, 4 new clergy received assistance with seminary debt, and 3 retired clergy received financial support for emergency situations. While this just seems like a lot of numbers, it in fact reflects lives changed through the generosity of our donors. Many recipients were identified by the donors who created the endowments. 

Pastors do a lot of driving. Rev. Ray (Bud) Probasco understood that better than many. Responding to a tragic accident that was caused in part by old tires, Pastor Probasco wanted to make sure that no pastors in the future would be unsafe driving on old, bald tires. Thus, in 2016 he started the tire fund. Many pastors in need have received new tires providing them with many more safe hours on the road as they traveled to visit their sick and shut-in. In 2020, five pastors from various districts received help from this fund. Pastor Max Milton at Argos UMC was one such pastor and he shared:

MT. AUBURN UNITED METHODIST CHURCH — CHALLENGES AND CELEBRATIONS

The COVID-19 pandemic brought so many challenges that it seemed the whole country, and even the world, was unprepared. Like many other churches, when the pandemic hit, the leaders at Mt. Auburn United Methodist Church knew its ministries needed to continue. There were a lot of challenges, to be sure. Much of its congregational life temporarily changed in order to navigate the pandemic, but the heart of its mission didn't change. It is still serving the people of its community.

Like most other churches, it suspended live services several months in 2020. During this time, it continued having on-line services and many of its ministries continued on Zoom with hybrid formats. It also had a loan they had been working diligently to pay off and did not want to break the momentum.

In 2007 the church leadership began construction of a 25,000 square foot addition including a family life center. This in itself was a big project. From the beginning the church planned to set aside a tithe of 10% of the funds to build a church in Uganda. This would be the first fruits from its capital campaign. In March 2009, the Trinity United Methodist Church in Uganda was dedicated. The Mt. Auburn congregation still supports the missionaries and this church. The O'Dell Family Life Center at Mt. Auburn was finished in October 2009 and has been well used by this community. Although it had a very successful capital campaign, there was still debt remaining from this project.

**DeVon Yoho
1942-2020**

DeVon Yoho was a founding member of the Board of Directors of the United Methodist Foundation of Indiana (UMFI). Originally starting his service with the former North Indiana United Methodist Foundation board in 2007, he served until its merger in 2011 and continued serving on the UMFI Board the maximum 9 years. He also served on the Board of Directors of the IN U.M. Loan & Savings Ministry (LSM) and continued to serve on the Finance Committee of UMFI as a non-board member until his passing on November 25, 2020.



DeVon was born May 12, 1942, to Wallace and Evelyn Yoho. He was married to Mary Etta Yoho for 52 years. They lived in Muncie from 1978 to 2017, raising their two children, and then moved to Westfield, to be closer to their children and grandchildren after DeVon's retirement from Ball State.

Dr. Yoho was an associate professor of Economics and Director of the Center for Economic Education at Ball State University for 34 years, retiring in 2012. He brought an understanding of the economics of the investment world, as well as non-profit businesses that both informed and directed the UMFI and LSM ministries.

DeVon had a passion for education and helped to form the educational outreach of the UMFI ministry. He also was passionate about congregational life. He served for many years on the Board of the IN U.M. Loan & Savings Ministry helping to find the best possible financing for many congregations seeking funding for their congregational projects. He could always be counted on to provide a unique perspective of a situation and was tireless in pushing both ministries to be the best they could. He actively participated in board meetings, passionately expressing his opinions, both on the matters of business and the necessity for cookies.

DeVon is survived by his wife of 52 years, Mary Etta; children, Lance L. (wife, Connie) Yoho and Rachel A. (husband, Jeff) Blacker; grandchildren, Brandon (wife, Madison) Yoho and Craig Yoho, Amy Blacker and David Blacker; brother, Wallace (wife, Pat) Yoho; sister, Susan Bergo; brother-in-law, Allen Meyer; nieces, nephews, and cousins. He was preceded in death by his parents; brother, David Yoho; brother-in-law, Dennis Bergo; brother-in-law, Norman Meyer; sister-in-law, Julie Meyer; nephew, Jonathan Bergo. To all of those who knew and loved DeVon, we share your love and loss and extend our sincerest sympathy. DeVon was truly a great man and left many wonderful legacies, his impact on UMFI and LSM is but one of many.

UMFI manages \$62 million in investments on behalf of 202 congregations and ministries in our Conference. This is in addition to the \$28 million of endowments, trusts and other funds UMFI manages on behalf of our donors.

The Investment Service Fund is a pool of market-based assets UMFI manages on behalf of local congregations. These funds represent endowments and other long term funds held by local churches. We provide access to funds that are screened to be in compliance with the Social Principles of the United Methodist Church. 2020 was a great year for stock returns and we are very proud to offer these socially screened funds that significantly outperformed their benchmarks. Through these funds, local congregations and agencies in Indiana earned more than \$16.6 million to be used in their local communities. Below is a summary of the returns for UMFI ISF funds.




CHANGE IS NOT SO DIFFERENT

In July 2020, the Loan & Savings Ministry (LSM) restructured from a separately incorporated organization to a limited liability corporation with the United Methodist Foundation (UMFI) as the sole member. Translated, this means while LSM still functions as a separate ministry, we now have one board of directors that manages both ministries. The staff will continue as they have in the past, so from the outside it will appear there is no difference, except with the financial statements. With the restructuring and one board, we are required to provide consolidated financial statements. Separate statements are available in the full audited financial statements.

With the restructuring, the financial statements will be unique this year. Since the Loan & Savings Ministry was “acquired” by the Foundation on July 1, the first half of 2020 LSM operations are reflected in the \$1,704,932 equity transfer from LSM. The interest income from mortgage loans and the interest expense from LSM deposits only represents the last 6 months of the year.
